PROCUREMENT / APPOINTMENT OF TAX ADVISOR ON RETAINERSHIP
BASIS FOR PIAHCL

1. The **PIAHCL (Accounts & Finance)** has reserved Funds for the procurement planned for FY **2026-27**. The **PIAHCL (Accounts & Finance)** intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the consultancy services of “**PROCUREMENT / APPOINTMENT OF TAX ADVISOR ON RETAINERSHIP BASIS FOR PIAHCL**” with the reference of “**P62174**”
2. The **PIAHCL (Accounts & Finance)** invites RFP through **EPADS v2.0** from eligible Bidders registered on **EPADS v2.0** for provision of Consultancy Services.
3. **Single Stage-One Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
4. All proposals must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of Pay **Order** or Bid Securing Declaration on the prescribed format described.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://epads.gov.pk/opportunities/federal/procurements/62174>.
6. The RFP, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Friday, July 31, 2026 04:00 PM**. Proposals will be opened on the same day at **Friday, July 31, 2026 04:30 PM**. Manual submission of RFPs shall not be entertained. Those consultants/Firm who have not yet registered on the new version of **EPADS v2.0**, may register themselves on <https://vendors.epads.gov.pk/>.
